Corporate Information – ISIN details



- ❑ NSDL generates ISINs for all securities issued in India, except G-Secs
- ❑ Issuer submits required documents to NSDL
- ❑ Issuer information is captured in NSDL systems
- ❑ ISIN is allocated and activated by NSDL
 - 17,500+ Issuers
 - 68,000+ Active ISIN's
- ❑ ISIN Information is made available to Investors
 - Full name of the Company
 - Address of the Regd. office including telephone, fax nos. and email address
 - Old name(s) of the company, in case company has previously changed its name
 - Security details (Mentioning Face Value /Paid-up Value per Security)
 - Details of R&T Agent

- ❑ NSDL has developed a website for dissemination of authentic & complete information enabling investors to view the information at a single place in an easy, fast & transparent manner (www.indiabondinfo.nsdl.com)

- ❑ An interface on Centralized Database for Corporate Bonds/ Debentures for updating ISIN information have been provided to
 - Stock Exchanges
 - Credit Rating Agency
 - Debenture Trustees

- ❑ As on August 2017, information related to more than 14,500 ISINs are available to
 - Investors
 - Stock Exchanges
 - Credit Rating Agencies
 - Debenture Trustees

Promoter Holdings



- Issuer / Registrar are required to provide Promoter / Promoter Group details to NSDL
- NSDL identifies Securities Accounts of the Promoters (Based on PAN)
- NSDL provides Promoter information pertaining to transactions and holdings in equity shares of listed companies directly to stock exchange on a daily basis for dissemination and necessary disclosures



e-Notices



- NSDL has developed e-notices facility to facilitate companies to send the Annual Report/Notices/any other communications to its members on their e-mail IDs

- Buy Back intimations to Investors

- Company De-listing intimations to Investors

- Interim / Final Dividend Intimation to Investors



e-Voting



- Mandatory for all listed companies
 - NSDL system has modules for retail clients and institutional clients having custodians

- NSDL offers Remote e-voting as well as Venue e-Voting

- Remote e-voting
 - Available on internet
 - Clients are issued login credentials by NSDL
 - Single sign-on integration with leading online brokers

- Venue e-voting
 - e-voting continues into meeting venue
 - Tablet based voting on wireless network
 - Voting stations and in-seat voting
 - NSDL sets up entire infrastructure

- Live Streaming of General Meetings

- Consolidated Results available immediately after close of voting
