

Basic Settlement Flow




- Connection with nearly 40 markets


Account Structure

Corporate Action Flow





For Issuers

DRs enable issuers

- Access overseas capital markets
- Establish international presence
- Broaden and diversify shareholder base
- Expand opportunity to increase local share price as a result of global demand

For Investors

DRs aid investors by

- Facilitating investment in overseas securities
- Diversification of investment portfolio
- Permitting dividend payments in home currency and notifying corporate action in respective language



DR Corporate Action Procedure



General Timeline for AGM & Dividend

20 days prior to AGM

- Notify record date for AGM
- Request for DR holder list

Record date for AGM

Notify outstanding ordinary shares as of record date

3 days prior to AGM

• Receives the company final voting result from depositary

AGM


- KSD attends AGM of the company
- Report AGM result

Within 30 days after the AGM

- The company pays dividend
- KSD remit dividends to the depositary after withholding taxes




Inter-CSD Direct Link for Dual Listing




